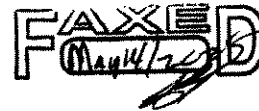

Dear Mr. Michaud,

Re: Food and Drugs Act – Natural Health Product Regulations 5 June SOR/2003-196 P.C. 2003-847.

Our firm faxed your office an urgent request for a hearing and investigation into this regulation on April 18th, 2005 [see Exhibit A] being the covering letter attached.

Please immediately confirm receipt of both of our communications and advise of the status of manner, as to date our records indicate that there has not been any response.

As indicated in our April 17th, 2005 letter there is urgency to this manner as our client's business is being destroyed as a result of the new federal regulatory actions claiming authority under these regulations.

There has been further incidents – see Exhibit B and C attached.

It is our contention that these are dietary food supplements legislatively in Canada and that the Canadian Border Services Agency [CBSA] has not only erred in accepting Health Canada's recommendations, but that Health Canada is not the legally authorized department to even be involved in reviewing our client's shipments.

These products routinely have been coming into Canada for many years without issue not only via our client, but all across the country via others as well and are normally reviewed and cleared by the CFIA.

Health Canada and the local CBSA officials for some yet unknown reason appears to be targeting our client with bias, unlawful and unfair regulatory harassment deliberately designed to close down our client's business.

Not only is this potentially a civil and criminal issues, but it is also a Human Rights and NAFTA issue as well. Our client has been operating legally for over 14 years without issue specializing in importing into Canada US manufactured dietary food supplements from well known quality US companies. For some yet unknown reason starting in December 2004 and escalating into this full blown nightmare in April 2005 CBSA officials in conjunction with the Health Canada officials have concocted bizarre and unsustainable allegations to use their legislative authority in a malicious and vicious fashion with total disregard for our client's inherent and inalienable constitutional and common law rights as well as international trade agreements.

We met on Wednesday May 4th, 2005 with the US Consulate in Montreal and filed an official complaint.

We presented this issue on May 9th, 2005 to the federal Committee on Health in Ottawa during witness hearings on our Health Freedom Bill C-420 and will pursue every possible legal and political channel to get these officials fired and or jailed and or a civil judgment against them personally and to force the government to stop the interference with our client's rights to earn a livelihood and his civil and property rights.

We have had our client in another one of our cases sue personally all of the federal officials involved as well as the government and the federal officials are not doing very well under examinations.

Our client requires immediate assistance on these issues.
